RESOLUTION NO. 136463

A resolution ratifying a Third Professional Services Agreement continuing in substance the Second Professional Services Agreement between the Parish of Jefferson and **Bryant Hammett & Associates**, **LLC** to provide construction and management services for programs funded by the U.S. Department of Housing and Urban Development, including but not limited to services related to the Hurricane Isaac Homeowners Assistance Program (HAP) and other similar disaster recovers or disaster resiliency housing programs, under the direction of the Jefferson Parish Department of Community Development, for a new termination date of May 3, 2021. (Parishwide)

WHEREAS, PARISH and Bryant Hammett & Associates, LLC entered into a Professional Services Agreement dated June 18, 2019, (hereinafter, Original Agreement) pursuant to Resolution No. 133529, adopted May 8, 2019, to provide construction and management services for programs funded by the U.S. Department of Housing and Urban Development, to include, but not limited to, services related to the Hurricane Isaac Homeowners Assistance Program (HAP) and other similar disaster recovery of disaster resiliency housing programs under the direction of the Jefferson Parish Department of Community Development; and

WHEREAS, the original Agreement inadvertently expired on April 3, 2020; and WHEREAS, pursuant to Resolution No. 135580, adopted April 8, 2020, PARISH and Bryant Hammett & Associates, LLC executed an agreement continuing in substance, dated on July 7, 2020 (hereinafter "Second Agreement"), which was erroneously labeled "Amendment No. 1 to the Original Agreement"; and

WHEREAS, the Second Agreement extended the termination date until October 3, 2020; and

WHEREAS, PARISH and Bryant Hammett & Associates, LLC have unintentionally gone past the termination date of the Second Agreement for which the services provided by Bryant Hammett & Associates, LLC are still ongoing and required; and

WHEREAS, PARISH and Bryant Hammett & Associates, LLC wish to enter into a new agreement under the same terms and conditions as the Original Agreement, as continued in substance by the Second Agreement, except the term shall be from October 3, 2020 through May 3, 2021.

NOW THEREFORE, BE IT RESOLVED by the Jefferson Parish Council of Jefferson Parish, Louisiana, acting as governing authority of said Parish:

SECTION 1. That the Third Professional Services Agreement, continuing in substance the Original Agreement and the Second Professional Services Agreement, between **Bryant Hammett & Associates** to provide construction and management services for programs funded by the U.S. Department of Housing and Urban Development, including but not limited to services related to the Hurricane Isaac Homeowners Assistance Program (HAP) and other similar disaster recovery or disaster resiliency housing programs, under the direction of the Jefferson Parish Department of Community Development with a new termination date of May 3, 2021 is hereby ratified.

SECTION 2. That all costs associated with this Agreement shall be charged to 21310-1195-139-7331-13124-501

SECTION 3. That the Council Chairman or in his absence the Vice-Chairperson, be and is hereby authorized to sign any and all documents necessary to implement this resolution.

THIRD PROFESSIONAL SERVICES AGREEMENT **BETWEEN** THE PARISH OF JEFFERSON AND BRYANT HAMMETT & ASSOCIATES, LLC

STATE OF LOUISIANA PARISH OF JEFFERSON

This Third Professional Services Agreement (hereinafter "Third Agreement") is made and entered as of the date of full execution by the parties, as evidenced by the electronic signatures attached hereto, by and between the Parish of Jefferson, State of Louisiana, (hereinafter, referred to as "PARISH") represented herein by Ricky J. Templet, Council Chairman of the Jefferson Parish Council, the Parish's governing authority, duly authorized to act pursuant to Resolution No. 136463 adopted on the 14th day of October, 2020, and Bryant Hammett & Associates, LLC (hereinafter referred to as FIRM), duly authorized to do and doing business in the State of Louisiana, represented herein by Bryant O. Hammett, its Owner/Manager. PARISH and FIRM may be referred to herein as "PARTY," individually, and "PARTIES," collectively.

WHEREAS, PARISH and FIRM entered into a Professional Services Agreement dated June 18, 2019, (hereinafter, Original Agreement) pursuant to Resolution No. 133529, adopted May 8, 2019, to provide construction and management services for programs funded by the U.S. Department of Housing and Urban Development, to include, but not limited to, services related to the Hurricane Isaac Homeowners Assistance Program (HAP) and other similar disaster recovery of disaster resiliency housing programs under the direction of the Jefferson Parish Department of Community Development; and

WHEREAS, the original Agreement inadvertently expired on April 3, 2020; and

WHEREAS, pursuant to Resolution No. 135580, adopted April 8, 2020, PARISH and FIRM executed an agreement continuing in substance, dated on July 7, 2020 (hereinafter "Second Agreement"), which was erroneously labeled "Amendment No. 1 to the Original Agreement"; and

WHEREAS, the Second Agreement extended the termination date until October 3, 2020; and WHEREAS, PARISH and FIRM have unintentionally gone past the termination date of the Second Agreement for which the services provided by FIRM are still ongoing and required; and

WHEREAS, PARISH and FIRM wish to enter into a new agreement under the same terms and conditions as the Original Agreement, as continued in substance by the Second Agreement, except the term shall be from October 3, 2020 through May 3, 2021.

NOW, THEREFORE, the PARTIES do hereby agree to the following:

All terms and conditions of the Original Agreement dated June 18, 2019, as ratified by Resolution No. 133529, adopted May 8, 2019, and as continued in substance by the Second Agreement, dated July 7, 2020, as ratified by resolution 135580, adopted April 8, 2020, are to remain unchanged and are to be incorporated herein as if wholly written, except the term of the contract shall terminate on May 3, 2021.
