A written examination will be given in approximately sixty (60) days, on a competitive basis to approved applicants for the purpose of placing names on the promotional employment list for the class of **Fire Lieutenant**; in accordance with provisions of the Municipal Fire and Police Civil Service Law and the rules of the Jefferson Parish Civil Service Board.

Application forms may be obtained from the Jefferson Parish Fire Civil Service Board Office located in the Joseph Yenni Building, 1221 Elmwood Park Blvd., Suite 404, Jefferson, LA 70123 Monday through Friday between 9:00 A.M. and 4:00 P.M or a copy of the Competitive Examination Application can be obtained on-line and printed from the Office of State Examiners website www.ose.louisiana.gov.

Completed applications and the required attachments must be received by the board's secretary, by email (penny.frame@jeffparish.net) or at the address listed above NO LATER THAN 4:00 pm on Tuesday July 9, 2024. Applications dropped in the door slot at Suite 404 MUST be date stamped. Any application that is submitted beyond the deadline date will be rejected. Approved applicants will be notified of the exact date, time and place of the examination at least five (5) days prior to the examination date.

QUALIFICATION REQUIREMENTS

FIRE LIEUTENANT

Unless otherwise specified, all requirements must be met by the filing deadline for application for admission to examination.

The applicant must meet all requirements of the Municipal Fire and Police Civil Service Law, including being a citizen of the United States and of legal age.

The applicant must possess a valid driver's license.

The applicant must be a regular and permanent employee probationally appointed to the class of Fire Equipment Operator at least three (3) years prior to the examination and have a minimum of ten (10) years combined experience probationally or permanently appointed in the classes of Firefighter and/or Fire Equipment Operator immediately preceding the examination.

Prior to confirmation to the class, the applicant must have thirty (30) hours of approved instruction of which eight (8) hours must be in supervisory management.
