In January 2021, JPRD implemented the Playground Participation Selection Policy, with the goal to increase participation, give participants a choice in which playground their child can participate, and elevate the quality of youth programming at playgrounds across the Parish. Below are important Playground Selection Policy Guidelines. For a more detailed explanation of our Waiver/Participant Selection Policy, refer to our JPRD PLAYGROUND PARTICIPATION SELECTION POLICY ONLINE.

- A. Participants that reside in unincorporated Jefferson Parish (Gretna, Harahan, Kenner, Westwego) must sit out one (1) year of All-Stars from the date of waiver approval and pay a \$150 fee annually, per family. RECREATION IS NOT ACCEPTING NEW WAIVERS TO GIRARD PLAYGROUND OR LAKESHORE PLAYGROUND.
- B. Participants that reside outside of Jefferson Parish (Orleans, Plaquemines, St. Bernard, St. Charles, etc.) must sit out the first two (2) years of All-Stars from the date of waiver approved and pay a \$150 fee annually per family. RECREATION IS NOT ACCEPTING NEW WAIVERS TO GIRARD PLAYGROUND OR LAKESHORE PLAYGROUND.

C. Waivers must be renewed each year. The waiver will become invalid if the waiver and/or renewal fee is not submitted to the Recreation office before the expiration date, and the individual will be deemed ineligible.

WAIVER CHARGES (Make checks payable to JPRD):

- D. Participants on waiver from unincorporated Jefferson Parish or outside of Jefferson Parish may not be eligible for All-Stars if the franchise rules deem them ineligible. They may be allowed to play intramural All-Stars if they have completed their sit out stipulations.
- E. Participants that have already established a "Home" playground and want to waive to another playground and make this their new "Home" playground may apply for a waiver. Once approved, the participant will have to sit out once (1) year of All-Stars from the date of waiver approval and pay a one-time fee of \$25 per participant.
