

**Jefferson Parish Department of Community Development
Amendments to the Fiscal Year 2016 Action Plan**

Summary of Changes to the FY16 Action Plan

Reallocate CDBG EN funds remaining balances in the estimated amount of \$559,897.28 to Jefferson Parish Sewer Department to maintain and improve public infrastructure in Low- and Moderate-Income Areas and related matters.
