Summary of Changes to the FY19 Action Plan

Cancel CDBG Public Service SLLS Match Funds for the HESG Program at \$6,177
Add CDBG funded Public Infrastructure Community Center Improvements Activity.

Summary of Changes to the FY20 Action Plan

Add Jefferson Parish Parks and Recreation Department Seven Estimated (7) Summer Camps using CDBG COVID-19 funds estimated at \$80,000 to assist low-and moderate-income families and children impacted by COVID-19.
