

**Jefferson Parish Department of Community Development  
Amendments to the Fiscal Year 2020 Action Plan**

In accordance with Department of Housing and Urban Development (HUD) guidelines, Jefferson Parish is publishing this summary of proposed changes to the Jefferson HOME Consortium's Fiscal Year 2020 Action Plan for new CDBG-CVIII funding and activities. The proposed changes can be viewed by contacting the Jefferson Parish Department of Community Development, Planning Section at 504-736-6262.

**Summary of Changes to the FY20 Action Plan**

Due to COVID-19, there is new emergency funding for eligible CDBG-CV activities including, Housing, Public Services, Public Infrastructure, Economic Development and Administrative Costs. CDBG-CVIII funding is designed to prevent, prepare for, respond to and assist those economically impacted by COVID-19. These amendments to the Action Plan will allow for the allocation of CDBG-CVIII to provide needed and immediate assistance.

**Fiscal Year 2020 Action Plan for the Jefferson HOME Consortium Amendments**

Add Housing: Floodplain Management. \$150,000 FEMA Hazard Mitigation local match.

Add Mental Health. \$39,000 Responsibility House Family Counseling.

Add Legal Services. \$92,244 SLLS/Clean Slate.

Add Re-Entry. \$50,000 LaCORS ROSC.

Add Senior Programs. \$23,913 People Program for Seniors.

Add Health Training. \$72,200 HYPE Nurse Certificate Training.

Add Housing Counseling. \$20,000 Mount Hermon Baptist Church Housing Counseling.

Add Fair Housing. \$64,834 Cross Cultural Affairs Dept. to provide outreach and Hispanic Services.

Add Food Bank. \$100,000 Second Harvest Food Bank Meals Program.

Add Public Facilities and Infrastructure Improvements: Sewer Repairs. \$400,000 COVID-19 impacted sewers.

Add Activity Delivery. \$20,000 Activity Delivery in support of Parish Sewer improvements.

Add Economic Development: Revolving Loan Program. \$500,000 for Micro Enterprises impacted by COVID.

Add Administration: \$436,324 Jefferson Parish Administrative Costs.

Add Contingency: \$213,108 Funds needed for eligible Grantee Contingency including but not limited to unanticipated costs related to completion of COVID-19 response or other activities such as Housing, Public Services, Infrastructure and Economic Development.

**Total CDBG-CV3 Part A CPD CARES Act:       \$2,181,623**

**Amendments to the FY20 Action Plan**

As a result of the COVID-19 Pandemic HUD allocated a second tranche of CDBG-CV funding. The Jefferson HOME Consortium will allocate these CDBG-CV funds and apply for any available subsequent funding, waivers and other relief as appropriate.
