Paint used in homes built before 1978 may contain lead. Contact with lead could cause brain damage and other serious health problems in children and adults.

Qualified Homes May Receive:

- Grants up to \$15,000 for lead hazard repairs
- Complete project management service
- Free Lead Inspections & testing
- Free blood lead testing for children
- Additional funds for other safety/housing issues such as mold, pests and security

Homes Must Meet The Following Criteria:

- Must be built before 1978
- Occupants must be low to moderate income
- Homes where children under 6 years old live or visit
- Homes must contain lead-based paint
