Under the provisions of the Disaster Relief Appropriations Act, 2013, all funds obligated by the grant agreement must be expended within two years of the executed grant agreement. Jefferson Parish's CDBG disaster recovery line of credit will be accessible through HUD's Disaster Recovery Grant Reporting (DRGR) system. Please be advised that Jefferson Parish is required to report on its use of CDBG-DR funds outlined in the Action Plan through the DRGR. The DRGR reporting requirements are outlined in detail in a Federal Register Notice published March 5, 2013 at 78 FR 14329 (incorporated by reference in the Notice published May 29, 2013 at 78 FR 32262).
