I write today in support of Cornerstone Chemical Company, and I sincerely appreciate you taking time to read my email. As one of your constituents and an employee of Cornerstone, I request that you please support the ordinance that approves Cornerstone's permit to modernize its HCN facilities. Consideration of the ordinance is expected to be on the agenda at the council's meeting on June 2.

I understand that prior to the last meeting held on May 13, there were 40 emails submitted by community individuals in opposition and only 18 in support of granting our permit request, however, I do not think this single fact tells the whole story.

It is far easier to lead an opposition to something that you are fearful of and that you do not fully understand rather than to do the time consuming research it takes to get all the correct facts.

For example, one of the items submitted by a member of the public prior to the last meeting as "proof" of a Cornerstone environmental violation was in fact a request from the EPA for information, and not a notice of violation.

Also, the public may not realize they themselves are a significant source of unregulated releases of toxic materials to the environment. This is why for the last 21 years the local chemical industry (Cornerstone included) have sponsored an annual "Household Hazardous Materials Collection Day (HHMCD). I have personally participated in this event. In 2019, the event removed 17.25 TONS of hazardous materials that would have otherwise found its way into our local landfills. The event was postponed this year due to COVID-19. It will be back!

The processing of HCN has been conducted on the Cornerstone site for more than 50 years. I myself have worked on this site for the past 28 years and frankly feel safer on the site than I do driving to and from the site!

During that time I rose from a maintenance technician to a senior maintenance manager. I am retired now and do some chemical plant consulting. I am very familiar with Cornerstone plant and there safety programs. They have been making hydrogen cynide at this plant for over forty years. The technology they use is forty years old. I would feel much safer if they made Hydrogen cydnide with the latest technology and safety systems. My only stipulations would be they would not be allowed to ship hydrogen cydnide out of the plant, not by truck,rail or barge. They be limited to 90 million lbs for internal use only. I would like for and outside consulting firm hired by the parish, review the dispersion model for this chemical, and communicate the results to the council and the affected communities.

I know firsthand that Cornerstone has safely produced, handled and managed HCN at the Waggaman site since 1953 both as a stand-alone plant and as a co-product of acrylonitrile. The fact that most residents of Jefferson parish were surprised to learn this information only highlights the fact that Cornerstone has been an excellent environmental steward these many years. The proposed HCN facility will only make the facility safer for me, my co-workers and the community.

I have lived in Harahan for the last 20 years and the 10 years prior to that in old Jefferson. Jefferson Parish needs to support an industry providing good high paying jobs to its constituents. It especially needs to support companies declared as essential in the fight against COVID-19. We at Cornerstone have been doing our part to produce products that keep the world safe. For example, Cornerstone produces the HCN and sulfuric acid needed to make the protective barriers, referred to as social distancing shields, sneeze guards, or protective panels, that are being installed in grocery stores and other transactional spaces to help keep staff, customers and visitors safe and socially distant.

I'm writing in support of Cornerstone Chemical Plant's SPU for a Hydrogen Cyanide (HCN) unit. My wife and I have lived in Waggaman for the last 34 years and have raised two children here. Our oldest daughter and her husband live with our two small grandchildren within two miles of Cornerstone. I have no major concerns with this unit being built.

I have worked in the Petrochemical and refining industry for over 30 years and have seen vast improvements in process operating technology, safety systems applications and the HAZOP review process. Cornerstone's SPU request is a direct result of an improved operating process. Cornerstone is in the process of upgrading its Acrylonitrile process, and in order to meet contractual requirements, Cornerstone has chosen to build a small HCN producing unit instead of bringing in HCN by truck and railcar, which poses a much greater danger to the community.

Cornerstone's decision to build an HCN unit is by far the safest way to meet their HCN contractual requirements. As anticipated when the Cornerstone Chemical special use permit was revoked without some sort of negotiation period, there would be a lawsuit. And obviously there has been much discussion since this time last year with citizens, business leaders, parish administrators, and respective attorneys.

While the legal discussions have been confidential, it is reasonable to believe that a "settlement" includes give-and-take. And, I trust that you concur that a mutually beneficial agreement is typically better than a "one size fits all" court decision.
