The Old Metairie Commission (OMC) conducted the May 4th, 2023 Public Hearing at the Joseph S. Yenni Building in the Council Chambers, located on the 2nd Floor, 1221 Elmwood Park Blvd., Jefferson, LA 70123. Mr. McAlister proceeded to the agenda and opened the meeting at 9:01 a.m.

OM-2-23 574 Woodvine Ave., A request to amend OM-21-22 to construct a detached garage and assorted site changes with variances to the height requirements and the area requirements of the R-1D Rural Residential/OMNCD Old Metairie Neighborhood Conservation District, and with a legislative exception to the OMNCD massing angle regulations, on Lot 14, Square P, Metairie Club Gardens Subdivision, Jefferson Parish, LA, bounded by Metairie Golf Club & Golf Course and Falcon Rd., zoned R-1D/OMNCD. (Council District 5)
